I/We SANDHYA P. MAYUR (Name of the Trustee/Chairman/Principa/Director/Head/Registrar/Corresponden) of the CHOPDA EDUCATION SOCIETY CHOPDA, DIST- JALGAON (M.S.) (Name of the College / Institute / Trust/ Society, etc.) here by undertake a swarm affidavit about the fulfillment according to the norms and guidelines given by the N.C.T.E. (WRC). Our teacher Educational institute (B.Ed. Gen.) has opened from 1990-91.

- 1) Infrastructural, instructional and other facilities have provided as per the NCTE norms, standards and guidelines prescribed from time to time.
- 2) Admission of students, satisfying the eligibility conditions have made either on the basis of marks obtained in the qualifying examination or entrance examination conducted by the state Govt./University as per its policy.
- 3) There is reservation of seats for SC/ST/OBC/handicapped etc. per the policy of state Govt.
- 4) Admission to the Course have made only after recognition is granted by the concerned Regional Committee of the NCTE .
- 5) (a) The full time staff has appointed on regular basis as per the qualifications prescribed in the Norms and Standards through a reasonably wide advertisement and open selection on the basis of the recommendation of duly constituted Selection Committees.
(b) The part time staff has appointed as per the guidelines of the State Govt./the affiliating University.
- 6) The tuition and other fees will be charged at rates prescribed by the concerned state Govt./ affiliating University & after sanctioned Shikshan shulka samiti, Mumbai.
- 7) The academic and other staff of the institution (including part-time staff) have paid such salary as may be prescribed by the concerned State Govt./University from time to time.
- 8) The Management has discharge the statutory obligation relating to provident fund, pension, gratuity etc. in respect of all its employees.
- 9) The Management has made adequate funds available for providing satisfactory facilities and for proper programme implementation.
- 10) The Management has maintain (i) an Endowmwnt of Rs. 5.00 lacs (Rupees five lacs only/-) to be operated jointly by the authorized representative of the Management and an officer of the concerned Regional Committee and (ii) a reserve fund equivalent to three months salary of the staff.

- 11) The accounts of the institution are properly maintained and audited annually by the audit authorities or a Chartered Accountant, and will be open for inspection.
- 12) The Management has strictly followed all conditions and norms prescribed by NCTE from time to time, conduct the programme in all earnestness, and submit itself to inspection by the NCTE as required at any time.
- 13) In the event of non-compliance by the CHOPDA EDUCATION SOCIETY (Name of the Society/Trustee/College/Institution etc.) with regard to the norms and standards and any other condition laid down/prescribed by the NCTE from time to time, the NCTE or a body or a person authorized by it will be free to take all necessary measures for effecting withdrawal of its recognition or permission, without consideration of any other issue, and that all liabilities arising out of such a withdrawal would solely be that of the institution/Management.
- 14) The Management is not cause or allow discontinuation of the course in any year or for any batch, and that where compelled, it will seek the concurrence of NCTE for discontinuation on the completion of the year /batch.
- 15) The Management has seen, studied and understood the norms and conditions stipulated by the NCTE for grant of recognition to the programme proposed and feels that they are satisfied, or can be satisfied by the time to inspection, failing which it would be willing to accept an unfavourable decision.
- 16) The (College / Institution) by virtue of the approval given by the NCTE shall not automatically become claimant of any financial grant or assistance from the Central or State Govt. or support from the NCTE
